Hereby declare and agree

1. Recordings

1.1 Collaborator agrees to contribute (or has contributed) to the creation of recordings ("recordings") with creator, as a performer or in another production role, including photography or videography.

1.2 Collaborator acknowledges these may involve nude, sexual, erotic, or pornographic content, which will be used in works ("works") published and distributed by creator via F2F or otherwise.

2. Consent, license and Intellectual Property Rights

2.1 By signing this agreement, collaborator grants creator and F2F full and ongoing permission to, at their discretion, use, edit, and adapt the recordings and works they contributed to (including clips and stills); to copy, publish, distribute, and commercially exploit them worldwide via <https://f2f.com/>; and to use them in promotional materials, press, ads, and social media.

2.2 Collaborator understands that all decisions regarding the use of the recordings rest solely with creator and F2F.

2.3 Unless explicitly agreed otherwise in writing, no intellectual property rights and related rights, including but not limited to copyrights, trademark rights, brand rights and neighboring rights (hereinafter "**IP**") rights are transferred; only the usage rights described above.

2.4 Provided that creator adheres to this agreement, collaborator waives any claims based on IP or personal or moral rights (such as attribution and integrity) rights concerning the recordings and works.

3. Compensation

3.1 F2F will distribute any earnings generated in relation to the content to the creator. The collaborator shall not receive any compensation from F2F for participating in the recordings or providing consent; any such compensation, if applicable, shall be arranged directly between the creator and the collaborator.

4. Warranties, indemnities & competent court

4.1 Collaborator confirms that they possess all necessary rights, licenses, and permissions to enter into this agreement; that they are of legal age in their country of residence; and that they are authorized to contract in their own name. They confirm they have read and understood this agreement prior to signing. They agree to indemnify and hold harmless creator and their partners from any claims, damages, or costs (including legal fees) arising from a breach of these statements.

4.2 Unless mandatory law provides otherwise, this agreement is governed by Dutch law. Any disputes will be submitted to the competent court in Amsterdam, The Netherlands.
